Status of Autonomy Application:

Our institution has applied for autonomous status, and the inspection by the University of Calicut has been completed. We are currently awaiting the formal conferment of autonomy.

Internal Quality Assurance Cell (IQAC):

The IQAC was established in 2005 and has been modified to include two external peer team members, as per Regulation 9.1. The IQAC will continue to monitor and report the performance of the college, and external peer reviews will be conducted at least once a year. The reports will be published on the college website.

Website Compliance:

Information regarding courses offered, fee structure, faculty details (with qualifications and unique IDs), admission procedures, infrastructure details, and research activities (including details of Ph.D. students, enrollment dates, topics, and supervisors) has been updated on the college website.

As per Regulation 9.4, once the autonomy is conferred, various Committees/Cells mandated under UGC Regulations will be constituted, as they require nominations from the state government and the university. These details will be updated on the website in due course. The institution will regularly update all required information on the website and any web portals specified by the UGC.

Research & Development Cell: A Research and Development Cell has been established to promote a research culture, facilitate grant applications, and monitor research activities among faculty and students.
