Research Innovation & Startup Ecosystem is the Technology Business Incubator hosted by Sullamussalam Science College. RISE aims to ensure that backward, rural minority classes of the Malabar region become an active part of a global economy and leaders in developing innovative, sustainable & successful technology. There are very few TBIs in the Malabar region, which also hosts one of the most densely populated districts in the state, Malappuram. The human resources in this region are often overlooked due to lack of ample higher education institutions as well as other socio-cultural factors.

RISE aims to ensure that the local youth get ample opportunities to make use of its resources to incorporate global technology to find solutions for local problems and cultivate a new culture that incorporates both local & global trends.

- **Journey of RISE established at the institute**

Our college is proud to house an established Innovation and Entrepreneurship Development Center (IEDC) since 2015, which has recently undergone an exciting transformation. In 2022, it was upgraded to a Technology Business Incubator (TBI), the Research Innovation & Startup Ecosystem (RISE), with a grant from the Kerala Startup Mission. Sullamussalam Science College became the first Arts & Science college in Kerala to establish a TBI, reflecting our commitment to fostering entrepreneurial talent among our students. Now, registered as a Section 8 Company under the name, **Sullamussalam Foundation for Rural & Women Startup Promotion**, RISE provides infrastructure, technology, finance, research assistance, mentorship, and consultation to startups. It is open to students, faculty, alumni, Areekode natives, and the youth of Malappuram. The TBI aims to create job opportunities and transform the Areekode & Malabar region into a globally recognized technological hub.

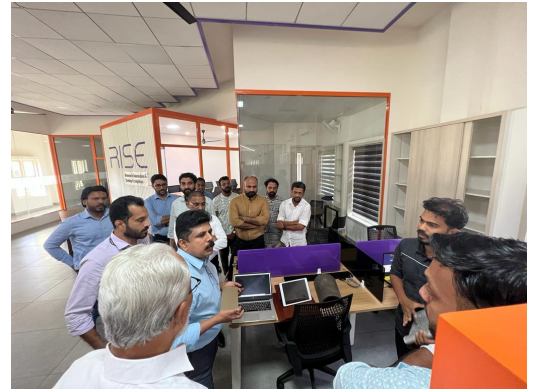

I. Conclusion

1.Startup Incubation: Over the past year, we have successfully incubated 10 companies representing diverse industry sectors, and notably, two of these startups have emerged from our own student body. This reflects the fertile ground for innovation that our institution provides.

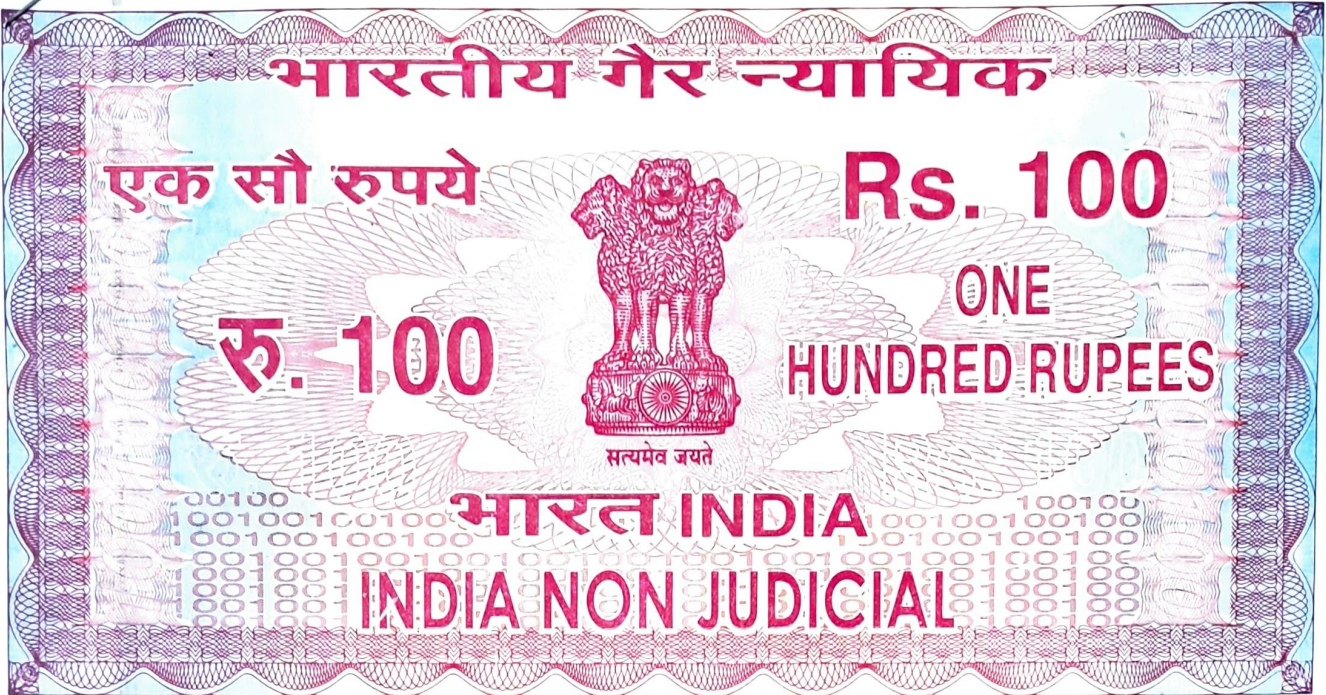

This Memorandum of Agreement (the "MOA") is made on this the 31st day of March, 2022 at 2 P.M

BETWEEN:

Technopark Technology Business Incubator (Kerala Startup Mission), a society registered under the Travancore Cochin Literary, Scientific and Charitable Society Act of 1955, having its Registered office at, Technopark Campus, Kariyavattom, Thiruvananthapuram 695-581, Kerala represented by its Chief Executive officer _____ (Hereinafter called **KSUM**) which expression shall include its successors and assigns) of the **FIRST PART**

AND

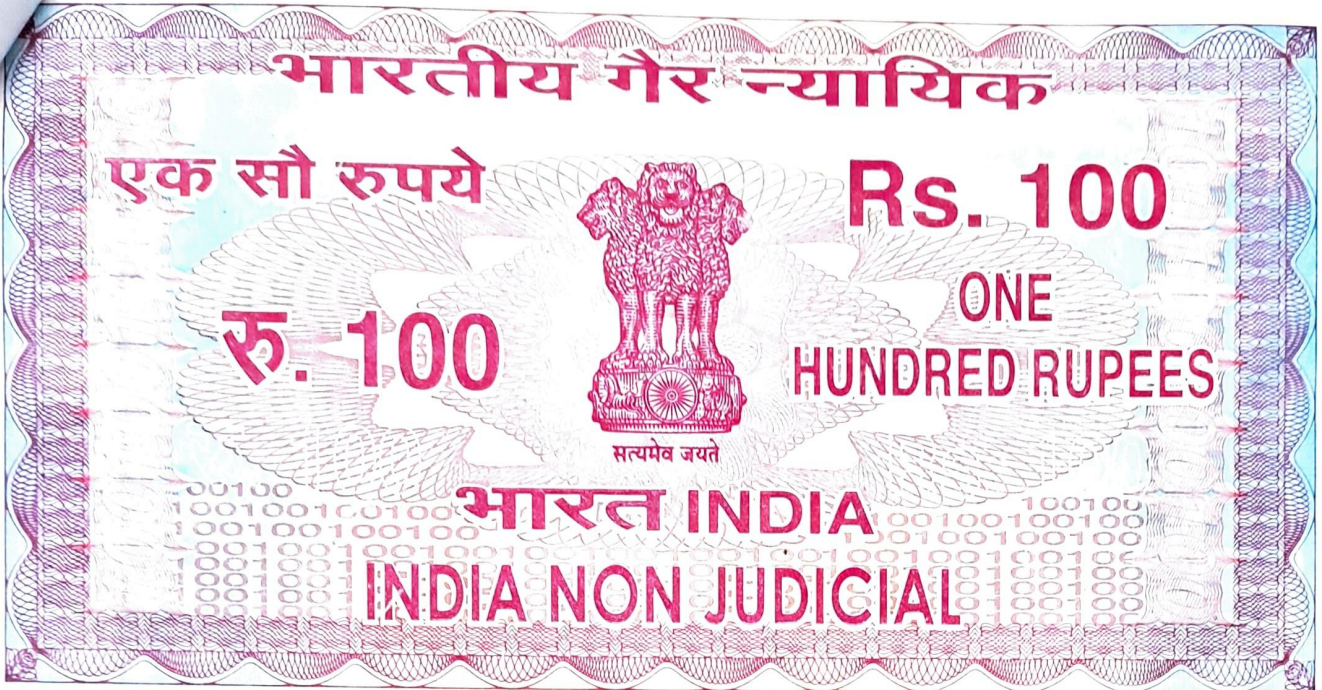

College is working as IEDC- Innovation and Entrepreneur Development Centre, for the development of new entrepreneurs and to promote innovation.

College has developed itself to the category of Incubator as per the Incubator guidelines of the Startup Mission and hence has proposed to be elevated to the position of Incubator .

KSUM after analysing the College as per the above guidelines has agreed to elevate the status of the College from IEDC to Incubator based on the below terms and conditions.

1. Obligation of INCUBATOR

The Government of Kerala, in its Kerala Startup Policy 2017, has recommended setting up of Technology Business Incubators to create sufficient area for incubation of startups. As per the Policy Government has issued orders in G.O (Rt) No. 285/2017/ITD dated 12.11.2017 for implementing the scheme for establishment of space for supporting incubators. In furtherance of this, the College has approached KSUM for supporting to set up a incubator with special focus on student entrepreneurs at the space available with them having an area of

The College has undertaken the following: -

1. Min 2,000 sq feet space will be provided by COLLEGE exclusively for setting up the incubator with capital assistance from KSUM.
2. COLLEGE shall preserve the Mission and Vision of the proposed Incubator and generate outcomes as projected in the proposal submitted to KSUM.
3. The College shall provide the infrastructure , operations and necessary man power for the effective and smooth functioning of the Incubator .
4. The COLLEGE will run the incubator for a minimum period of five years.
5. The COLLEGE will submit audited financial statements of the incubator with capital assistance of KSUM
6. The COLLEGE will make necessary arrangements to run the incubator in effective manner
7. The COLLEGE will provide space in the incubator only to startups as defined by KSUM
8. The COLLEGE will maintain a regular roster of startups which is accessible to KSUM for inspection at any time during the first five years of operation
9. The COLLEGE will arrange to register all the incubate companies at the premises in the KSUM Portal as and when they get enrolled for incubation.
10. The COLLEGE will ensure proper maintenance of the premises furnished by using funds from KSUM for a period of 5 years
11. In the event of the closure of the incubation facility before 5 years of functioning of the incubator, the COLLEGE will refund 20% of the capital cost given by the KSUM for every non completed years along with 12% annual interest accrued from the date of release of fund by KSUM up to the date of refund.

Obligation of the KSUM.

Now this MOA witnesseth as follows:

1. The Assistance Amount granted to COLLEGE shall be used solely for the purposes for which it has been granted by the **KSUM**, and for no other purpose. No additional grant will be approved for further extension of spaces or refurbishment of existing spaces there on. The amount of Rs. 10 lakhs granted

under this agreement is a one time incubation support extended by the KSUM to the College.

2. The Assistance Amount shall be released as follows:

An advance of 50% of the grant amount will be given to COLLEGE on award of the work for payment of advance.

The balance 50% amount will be released in a two instalments (30% of grant as 2nd and 3rd instalments and 20% of the grant as final instalment) based on the performance evaluation and recommendation by the Incubator review committee.

3. The instalments will be released on recommendation of the Incubator Review Committee constituted by the Kerala Startup Mission after verification of the documents and site visit if found necessary
4. COLLEGE hereby represents and warrants that (i) COLLEGE is duly constituted in accordance with applicable laws in India; (ii) COLLEGE is authorised to execute this MOA, and to carry out any activities hereunder.
5. College shall not be considered for any further grants or supports from the KSUM in the even the terms of this agreement is violated by the College.
5. KSUM has, bases on the representation and assurance made by COLLEGE in accordance with the proposal mutually agreed upon, permitted COLLEGE to furnish the said premises.
6. KSUM hereby reserves the right to inspect the premises and connected and supporting documents on the furnishing work at any time it deems fit.

KSUM shall provide necessary training and guidelines to the college to run the incubator

7. The COLLEGE will be solely responsible for setting up and proper running of the incubator and KSUM shall provide necessary support and training for the same.
8. KSUM shall, in no way, be responsible for any grievance caused to the employees of any start-up in the incubator or anyone attached thereto, and the responsibility for the same shall be rest solely on KSUM.
9. This MOA shall be governed by and construed in accordance with the laws of India. Subject to the provisions of Clause 18 above, the **Courts at Thiruvananthapuram, Kerala** shall have exclusive Jurisdiction over any dispute arising in relation to this MOA.

10. Neither Party shall be liable for any failure or delay in performance of any obligation under this MOA to the extent such failure or delay is due to the occurrence of a force majeure events such as natural calamities, fire, riots, strikes, terrorism, explosion, etc. in such event, the affected Party shall immediately notify the other Party, in writing, of the nature of such cause and the expected delay.

11. Term of this Agreement

This Agreement shall be valid from the effective date of this agreement and it shall continue till the full grant amount is paid by the KSUM and the College has completed the establishment of Incubator in a functioning mode or 5 years from the date of the agreement , which ever is earlier.

12. Termination

KSUM shall terminate this agreement by giving 2 months notice to the College, in the event of any violation of the agreement by the College.

13. Indemnity

The College shall indemnify KSUM against any claims/ damages from any third parties, government, arising out of the College's misrepresentation, false claims, negligence, omission or ignorance

14. Confidentiality

Any information disclosed by one Party to the other Party should be treated by the other Party as confidential information if it is marked accordingly or appears as confidential to a reasonable person ("Confidential Information").

An Authority should use any information, including Confidential Information, disclosed to it by the other Party only for the purposes for which the information was disclosed, unless consent is obtained for other uses.

If either Party is required to disclose any Confidential Information provided to it by the other party pursuant to a requirement of law, such Party should, to the extent possible, notify the other Party prior to complying with such a requirement and should assert all appropriate legal exemptions or privileges with respect to such information as may be available.

15. Intellectual Property Rights
