# <u>ORDER</u>

As per the reference cited 1st, the guidelines for the Supervisors who have vacancy for supervision, even after publishing the list of vacancy, for admission of candidates who are holders of Junior Research Fellowships (JRF) from any Central / State agencies for Ph.D programme under their supervision, is implemented as given below.

"Research supervisors whose vacancies are not notified for the Ph.D. entrance examination or who have subsequently arisen vacancies can admit candidates who are holders of **Junior Research Fellowships (JRF) from any Central/State agencies for Ph.D programme under their supervision.** Such supervisors need to notify their vacancies in the website of the Research Departments/ Colleges with a direction that only JRF holders can apply. JRF holders need to submit an application and should appear for an interview before the Department Council of the research center as per the norms laid out by the University. A rank list needs to be prepared by the Department Council based on the interview. JRF candidates who have already submitted their application against the notified vacancies and are included in the shortlist can also apply for these new vacancies".

As per the reference cited 2nd, the Committee constituted for the preparation of guidelines for Ph.D. Admission of anytime category candidates held on 10.01.2023 recommended to modify the U.O. No. 15391/2022/Admn dated 10.08.2022, permitting the JRF holders for anytime Ph.D admission by notifying the vacancy at Research Centre, incorporating all other categories coming under the anytime category as per clause 4.2.1 to 4.2.4 of Ph.D. Regulation, 2016.

As per reference cited 3rd, considering the matter in detail, sanction has been accorded by the Vice Chancellor to modify the U.O No. 15391/2022/Admn dated 10.08.2022, by incorporating all other categories coming under the anytime Ph.D registration category candidates as per clause 4.2.1 to 4.2.4 of Ph.D. Regulation, 2016.

# The following orders are, therefore, issued.

Research supervisors whose vacancies are not notified for the Ph.D Entrance Examination or for the admission of Ph.D anytime registration category candidates or who have subsequently arisen vacancies can admit candidates who come under the following categories for Ph.D programme under their supervision, by following the guidelines for the Ph.D admission of anytime category candidates implemented vide U.O. cited 4th (appended herewith). Such candidates need to submit an application and should appear for an interview before the Department Council of the research centre as per the norms laid down by the University. A rank list needs to be prepared by the Department Council based on the interview.

# <u>Category of anytime Ph.D registration candidates (Calicut University Ph. D Regulation, 2016)</u>

4.2.1 - Candidates who qualify UGC-JRF, UGCCSIR-JRF, research fellowships of Central and State Government departments/agencies as approved by the University, as the case may be 4.2.2 - Full time regular teachers of the University Departments/ Govt. or Aided Colleges affiliated to the University of Calicut and teachers with FDP/QIP or similar fellowships.

4.2.3 - Foreign nationals who are otherwise eligible for admission.

4.2.4 - Full time fellows, who have been selected on the basis of a written test and interview, working in a research project under the investigation of a research guide of the University.

## <u>ORDER</u>

As per the paper read (1) above, a Committee was constituted to prepare the guidelines for Ph.D. admission of any time category candidates.

As per the paper read (2) above, the Committee constituted to prepare the guidelines for Ph.D. admission of any time category candidates held on 10.01.2023, approved the following guidelines for the Ph.D admission of any time category candidates.

## Procedure for admission.

a. The vacancy should be notified by the University/Research Centre.

b. The eligible candidates should report at the research centre within the date and time fixed by the University/Research Centres.

c. The vacancy ceases to exist after the last date fixed for reporting.

d. Interview should be conducted by the Research Centres and rank list should be published on the website and notice board of the Research Centre.

e. CAP ID (created during the concerned admission year) is mandatory for all candidates at the time of admission,

f. The admission procedure including the conduct of RAC should be completed within 30 days from the last date fixed for reporting for admission.

g. The admission should be granted in strict compliance of the reservation roster issued by the University vide U.O.No. 19032/2022/Admn dated 07.10.2022.

h. Those who have already submitted their application through DoA can also apply for these new vacancies.

i. The Research Centres can admit the candidates after issuing a joining memo in the format prescribed by the University.

j. After joining the candidate in the Research Centre, the proposal for issuing the final registration

order should be submitted by the candidate through the ONLINE RESEARCH PORTAL. The supervisor/ guide and the Head of the Research Centre should verify the details and documents entered by the candidates in the portal and forward the same to the DoR with proper certification. (An online familiarisation session will be provided to the Research Supervisors and the Heads of the Research Centre on the Online Research Portal)

k. The DoR will issue the final registration order after verifying the details/documents forwarded by the Head of the Research Centre granting registration from the date of joining in the research centre, if the proposal is in order.

I. Foreign Nationals may be exempted from all the above procedures and they may be admitted to Ph.D. programme anytime during the academic year depending on the willingness/availability of guides.

Sanction has been accorded by the Vice Chancellor, as per paper read (3) above, to implement the minutes of the committee constituted to prepare the guidelines for Ph.D. admission of any time category candidates

# <u>ORDER</u>

As per the reference cited as 1 st, it has been informed that in light of the direction from the Kerala State Higher Education Council, the clause in the University regulations, which mentions that Ph. D. Registration be granted to candidates, whose degrees are '**recognized as equivalent**' to the Masters Degree of the University of Calicut, should be read as '**recognized**' by the University of Calicut. Hence, equivalency need not be insisted upon for Ph. D. Registration once approval for registration is granted by Research Advisory Committee.

As per Clause 2.1 of the Calicut University Research Regulation 2016 " Candidates for admission to the Ph.D. programme shall have a Masters degree or a professional degree recognized as equivalent to the Masters degree of the University of Calicut, with at least grade ' B ' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) or at least 55% marks in aggregate in the mark system or an equivalent degree from a foreign educational institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions ".

After having considered the matter in detail, as per reference cited 2nd, sanction has been accorded by the Vice Chancellor to amend the clause 2.1 of Calicut University Research Regulations 2016 as furnished below:

As per the reference cited 3 rd, the amendment in the clause 2.1 of Calicut University Research regulations 2016, as detailed above, is implemented, subject to ratification by the Academic Council.

After considering the matter in detail, the Vice Chancellor has ordered to place the matter of ratifying the above action, before the Academic Council for consideration.

As per the reference cited 4th, the Academic council at It's meeting held on 15.12.20222, vide Item No III.243, resolved to approve the matter of ratifying the action of Vice Chancellor in having approved the amendment to Clause 2.1 (Eligibility criteria for admission to Ph.D program) of Calicut University Research Regulations 2016 as detailed in the Table above.

As per the reference cited 5th, sanction has been accorded by the Vice Chancellor to implement the above resolution of the Academic Council held on 15.12.2022 vide Item No.III.243 and the resolution is thus implemented.

## <u>ORDER</u>

As per the reference read as 1st, the Research Council at it's meeting held on 05.11.2022, considered the items placed by various sections with regards to Research, and resolved the matter as follows.

**Item No. 1:** The matter of granting guideship to the Lecturers in Non UGC stream (Note No;12843/RESEARCH-D-ASST-2/2021/Admn dated 03.06.2022).

**Resolution:** The Council resolved to get a confirmation from the applicants on their scale of pay and get clarification from UGC denoting their designation thereafter.

**Item No. 2:** The matter of granting additional Co-guideship to a faculty in foreign University and making clarity in Ph.D Rules & Regulations regarding the role of Co-guideship and credit earned by the Co-Guide for supervising the Scholar (U.O. Note No: 135342/RESEARCH-A-ASST-A/2021/Admn dated 16.02.2022).

**Resolution:** The Council resolved to collect request from the research scholars, recommendation from Research Advisory Committee, Ethical clearance from the Research center for considering the request. The council suggested to use the word joint guidance instead of co-guide and MOU between the organizations (Govt. College of Madapally and King Fahad University of Petroleum and Minerals, Saudi Arabia, in this case). The Committee resolved that joint guidance can be facilitated in interdisciplinary research were the credit of Ph.D will be distributed among the Supervisor and co supervisor.

**Item No.3:** The matter of granting an additional grant of Rs.5,000/- (maximum limit) to University Department students / research scholars for meeting user fees in CSIF in addition to the

contingency grant already granted to scholars availing University fellowship (Note No: 76269/CSIF ASST-1/2017/Admn dated.22.09.2021).

**Resolution:** The Council resolved to provide additional contingency of Rs.5000/- (five thousand only) for CSIF usage for Calicut University Campus Department research scholars. The student member of Research council reported that he is not supporting fee for CSIF usage for research scholars of the University Teaching Departments.

**Item No. 4:** The request submitted by Research Scholars to change the minimum duration of Ph.D course to two and a half years for M.Phil Degree holders, whose research is in same discipline (Note No:173814-RESEARCH-B-ASST-4/2021/Admn dated 12.11.2021).

**Resolution:** The Council resolved that applications or requests may be considered by Vice Chancellor case by case.

**Item No. 5:** The requests submitted by Research Scholars, who were registered for Ph.D Programme prior to July 11, 2009, for the UGC NET exemption certificate for appointment to the post of Assistant Professor in Universities and Colleges (Note No: 6774/RESEARCH-C-ASST-1/2015/Admn 17.01.2022).

**Resolution:** The Research Council resolved that the publication and paper presentation can be certified by Research Supervisor/Head of the Research Centre concerned and the period of Publication and Paper presentation should be within the research duration / before the open defence.

**Item No.6 :** The matter of Patents filed or awarded as equivalent to publication of one research paper and to include Patents filed or awarded also in the eligibility criteria for granting guideship as well as for thesis submission (Note No: 206779/RESEARCH-D-ASST-2/2021/Admn dated 17.06.2022).

**Resolution:** The Research Council resolved to amend the clause 5.1 and 8.1 regarding eligibility criteria for granting guide ship as well as for thesis submission. The University can encourage patent filing of the remarkable research works conducted in the University departments. Patent or patent filing certificate can be submitted for the remarks of the Dean of Faculty so as to consider as equivalent to publications. The Council added that in disciplines like Fine Arts/ Drama and Theatre/ Folklore Unique and master performance of the teachers can be considered as equivalent to publications if necessary evidence is submitted for the specific remarks of Dean of Faculty.

**Item No. 7:** To grant part time Ph.D registration to Higher Secondary School Teachers employed in schools situated outside the Geographical jurisdiction of this University (Request submitted by Smt. Sujatha. R. Menon, HSST, Govt. Model H.S.S for Boys, Thycaud). (Note No.65890/RESEARCH – DASST-1/2022/Admn dated 26.10.2022).

**Resolution:** The Research Council recommended to amend the Clause 2.8.2 regarding part time research as follows.

The Teachers of the Universities/Affiliated Colleges/Govt. Polytechnics/Teachers of the Government or Aided Secondary/Higher Secondary/ Upper Primary/ Lower Primary School in India holding a permanent position there, if they qualify other eligibility criteria and entrance test and are eligible for admission to Ph.D program satisfying the conditions of Clause 2.1 of the Calicut University Research Regulation 2016 may be granted Part-time registration. In the case of Assistant Professors who are working in the Colleges affiliated to University of Calicut/ University Teaching Departments/ School of Distance Education of this University, on contract basis, an undertaking from the Principal / Head of the Department / Director should be submitted along with the application for Part-time research that the Assistant Professor is in service.

**Item No. 8:** The request submitted by the Convener, All Kerala Research Scholars Association (AKRSA) for conducting Ph.D Preliminary Qualifying Examination as internal. (Note No.19748/RESEARCH-C-ASST-3/2019/Admn dated 05.11.2022).

**Resolution**: The Council recommended to conduct a Special Drive in Pareeksha Bhavan to meet the present delay in consultation with CE and Registrar. The Registrar offered human resource support of two Assistants for the completion of pending PQE of PhD. The council did not recommend to limit PQE to internal evaluation.

## Other Items:

1. The Director, DoR with the permission of Chair introduced the matter not having a U.O for anytime admission candidate (Except JRF) for taking admission from the vacancy of supervisors which are not notified by DOA. The Council resolved to take necessary steps to implement the same through U.O.

2. As there is reports from different departments related with limitation in infrastructure in accommodating Research Scholars, with the permission of the Chair, Director, DoR, presented the matter before the Council. After discussion, the Council resolved that the number of Research scholars as well as Supervisors should be limited as per the availability of the infra-structure of a University Department or Research centre. An undertaking in this regard should be received from the HOD so as to consider further entry of Research scholars or supervisors. Similar situations were reported from Department of Malayalam, Mathematics, Political Science and Physical Education.

3. The Council resolved to enhance the remuneration rate for the PhD valuation and suggested to bring it as a proposal to the Syndicate. The present rate is Rs. 2500/-, and the Council recommended to enhance it to Rs.4000/-. The Director, DoR reported that the section is receiving complaints from the adjudicators related to the delay in getting the remuneration as it is distributed as a onetime settlement. The Council recommended that the imprest can be allotted to Deputy Registrar, Directorate of Research so as to distribute the remuneration as per the valuation.

As per the reference cited 2nd, Vice Chancellor has ordered to place the above resolution of the Research Council held on 05.11.2022 before the Syndicate for it's consideration.

The Syndicate at it's meeting held on 30.12.2022, vide item No.2022.1505\*, considered the matter

and resolved to approve the resolution of the meeting of the Research Council held on 05.11.2022. The Syndicate resolution is implemented as per the reference read as second.

As per the reference read as third, the Academic Council at it's meeting held on 27.06.2023 considered the the minutes of the meeting of the Syndicate held on 30.12.2022, vide item No.2022.1505\* to approve the minutes of the meeting of the Research Council held on 05.11.2022 and resolved to approve the same with the following modifications;

With regard to the resolution in **item No.1** of the Minutes of the meeting of the Research Council held on 05.11.2022, the House observed that granting guideship to the Lecturers in Non UGC Stream will not be on the basis of their teaching in the programmes which are equivalent to Higher Secondary/Plus Two.

With regard to the resolution in **item No.8** of the Minutes of the meeting of the Research Council held on 05.11.2022, the House resolved to refer back the matter to the Research Council for detailed study.

After considering the matter in detail as per the reference cited fourth, sanction has been accorded by the Vice Chancellor to implement the resolution of the meeting of the Academic Council held on 27.06.2023 vide Item No.I.9

As per the Clause 2.8.2 of Calicut University Research Regulation 2016, the Teachers of the Universities/ Affiliated Colleges/ Government Polytechnics, in India/ employees of the University and holding a permanent position there/ Project Fellows who have been selected on the basis of a written test and interview and working in a research project under the investigation of a Research Guide of the University and the Teachers of the Government or Aided Secondary/ Higher Secondary/ Upper Primary/ Lower Primary School, holding permanent position within the geographical jurisdiction of the University of Calicut, if they qualify other eligibility criteria and entrance test and are eligible for admission to Ph.D programme satisfying the conditions of Clause 2.1 of the Calicut University Research Regulation 2016 may be granted Part-time registration.

After examining the case of Ms.Sudha R, Research Applicant, Department of Zoology, Christ College, Irinjalakuda working as HSST (Junior Zoology), in Govt. HSS Uduma, Kasargode, who applied for registration to Ph.D programme in Zoology, in Part time mode, sanction has been accorded by the Vice Chancellor in the file No. 295385/RESEARCH-B-ASST2/2022/Admn dated 06.05.2023, to amend the clause 2.8.2 (pertaining to the part time Ph.D registration of the school teachers) of Calicut University Research Regulations 2016 so that the jurisdictional restriction is lifted for school teachers who apply for part-time Ph.D registration, subject to ratification by the Academic Council.
